Taiwan's Recent Developments and its International Participations Director General Daniel Liao, Taipei Economic and Cultural Office in Seattle Rescheduled from our January meeting



We appreciate the willingness of Director General Liao to reschedule his talk to us. This year, as too often in the past, January weather led to canceling our meeting—too many of our members already are loath to drive after dark and with the weather predicting a snow storm on the way... we played it safe.

Director General Daniel Liao's experience over 30 years has taken him to many parts of the world in various capacities representing the government of Taiwan, and we are pleased to have him update us on the present issues facing the Taiwanese government and its people. The global economic crisis has meant for Taiwan, as for most countries, a rethinking of how it develops its economy as also how this relates to its economic relations with the United States and mainland China. He will focus on Taiwan's recent trade agreement with mainland China, as well as the upcoming trade talks between Taiwan and the United States and Taiwan's government procurement opportunities for American companies. He will also fill

us in on Taiwan's participation in the international organizations such as International Civil Aviation Organization as well as touch on the many cultural events that are provided by the Chinese Cultural Center in Seattle.

Also remember that this is your annual meeting and we will have a bit of business to conduct prior to this talk. Please see the enclosed financial reports.


The students will be here from March 22—April 2 and the above mentioned debate is scheduled for Friday, March 25th with a party to follow.

In Memoriam Vilis M Barevics

It was 1992 when a delegation from Bellevue headed to visit our about to be new Sister City, Liepaja in Latvia. Among the 20 delegates were the then City Manager, Phil Kushlan and Terry Lukens representing the City of Bellevue and three BSCA members of Latvian background – Zaiga Phillips, Imants Bitners and Vilis Barevics. This was the first of many visits Vilis was to pay to Liepaja over the next many years, some as a member of a

> visiting delegation, more often making Liepaja one of his stops during his annual visits to Latvia. Vilis was always willing to help out with translating for visiting exchange staff or other visitors from Liepaja. He enjoyed spending time with our summer





Even before he retired from Boeing in 1999 he found time for Liepaja committee activities. He was serving as chair of the Liepaja committee when in 2000 Max Clark, then BSCA president, moved to Boise, and was

asked to take over for Max. Vilis served as president until 2004. Along with Pat Hale he attended the 2002 SCI Conference and

was pleased to be the one to receive the award for Innovation in Education presented to the Liepaja Committee's project with the Liepaja Special School. During his tenure Bellevue celebrated its 50 year incor-



poration and BSCA was there to help host visiting Sister City representatives. And in 2003 Vilis, along with then Mayor Connie Marshall led our delegation to Hualien and Yao.

But his major contribution to BSCA was overseeing the implementation of the new bylaws restructuring BSCA into our present committee group-



ings, and our present financial structure which allows each committee discretion over their funds. His continued financial guidance throughout the years was much appreciated. We will miss him!

Remembering our Past Members

Over the years we have much appreciated that the families of our past members have requested memorial contributions to be sent to BSCA. Some of these contributions have been earmarked for a specific committee or even for a specified purpose. One such is the \$8,000 plus received in memory of Ann Knofel to be used for the Liepaja Special School, funds which will help pay for an outdoor playground for the school.

Over the past ten years other memorial funds to committees amount to over \$2,800, and contributions to the general fund to almost \$5,000. We have kept a record of these funds, and several times have discussed some way of using them to best to commemorate our past members. We are saddened by the death of one more person important to BSCA-**Vija Rekevics**, owner of OPUS 204, passed away on February 2nd. An overflowing crowd attended the memorial service held at the Latvian Center on the 25th – a tribute to her one-of-a-kind persona.

Some ideas have been put forward – one we have been following up on is some way of indicating that Bellevue does have four Sister Cities in the Concourse at City Hall. There are now 4 display cases in the hallway to the City Manger's offices on the second floor – but few of the general public actually go up there. How else might we use these funds to make BSCA more visible to Bellevue citizens? Or record the past history of BSCA and the contributions of so many?



Our new Kladno Chair—Heidi Ressler

Heidi's first introduction to BSCA was back in 2006 when a student at Interlake School and family participated in our summer exchange with Yao. The following year her daughter, Loren, was selected for the Kladno exchange and the family spent a month learning about the Czech Republic from the Kladno student, David. Then followed the month Lauren spent with David and his family in Kladno including a bus trip with David's mother to Paris – a highlight for Lauren! Heidi's memory of Lauren's return was her increased confidence and improved Spanish, as David's mother could only speak Czech, German or Spanish.

Lauren has moved on to college and continued her international explorations with a 4-month study abroad in 2009 to Ecuador. (see picture) Heidi joined her for 10 days at the end of term to meet her host family and explore the country. Lauren graduates this year from Seattle U with degree in Environmental Studies. She has maintained her friendship with David and other Czech students she met in 2007 via Facebook.

Heidi is ready to become an active member of BSCA having com-

pleted a 2-year term with City of Bellevue's Network on Aging. She is taking a break from Bellevue Schools PTA activities which included chairing "Reflections" artistic program at Highland M.S & Interlake H.S., as well as Scholarship co-chair at Interlake H.S., following as Bellevue District co-chair in 2010. Heidi maintains close ties to Interlake H.S., the only Bellevue school to offer the International Baccalaureate (IB) curriculum and was actively involved in the parent group from 2003-2007 during a period the district was considering discontinuing the program. On a daily basis Heidi works in personal insurance (home/auto) in Bellevue and enjoys the fact her commute to work is about 4 miles. Her husband, Brendon, works in Seattle and son, Quinn, attends Bellevue College.

Delegation Visit—September

Finally things are falling into place and looks like our delegation trip to our European sister cities is a go—we have heard both from Kladno and Liepaja and will now be working to finalize dates—mid to late September with the visit to Liepaja first and then on to Kladno.

From the response of those members interested in joining the delegation when we first broached the subject, a majority indicated that fall might work best for them as well as for our hosts.

As we plan for our visit there are several options we can consider—including a tour either at the end of the visit or even in between the city visits. In the past, some members have joined the group in Europe or stayed on to do additional touring let us know your preferences! A fist pass on a schedule is below-the flights either on KLM or Lufthansa and Czech Airlines— SAS no longer flies from Seattle...

Tues. Sept 13—depart Seattle for Riga via either Amsterdam or Frankfurt Wed. Sept 14th arrive Riga and to Liepaja Thurs-Fri. Sept. 15-16 in Liepaja Sat-Sun. Sept 17-18 weekend in Riga Mon. Sept 19th flight to Prague Tue.-Wed. Sept 20-21 in Kladno Thus—Sat. Sept. possible tour Sun. Sept. 25—Return to Seattle.

Another option might be to fly via Reykjavík on Icelandair, the fare might be better but that means extra changes of plane and an overnight in Iceland on the way home...

We will again be working with Elise at Rainier World Travel to get group rates.
